The undersigned, having familiarized themselves with the requirements affecting the cost of the work, the Invitation to Bid; Instruction to Bidders, this Bid Form, the form of the Bid Bond; the form of the Non-Collusive Affidavit; Payment Bonds; the General Conditions; the Special Conditions; the Prevailing Wage Decision; the Contracting and Employment Goals; and Addenda, if any thereto, on file in the office of the Peoria Housing Authority, hereby proposes to furnish all equipment, services, and material required.

The following principals shall govern the competitive bidding process:

1. The Peoria Housing Authority will award one contract to the acceptable contractor submitting the lowest, responsive and responsible base bid.
2. The contract will be a fixed price contract. The total contract amount shall not be exceeded without a written change order.
3. Items may be varied as needed to complete the work. The Bidder is advised to include in each of the items the proportional amounts of labor and material costs, overhead, profit, and fees.
4. The Peoria Housing Authority is tax-exempt and late fees cannot be imposed.
5. Contractor shall follow the "Buy American" requirements for the purchase of all iron, steel and manufactured goods. Contractor shall be required to submit verification of origin of all materials purchased to complete the contract. See special conditions for additional guidance.
6. Alternate Deducts may only be indicated by a deduction in cost. If the net result is an increase in cost, a zero dollar figure should be indicated.

BIDDER proposes to perform all work required in strict accordance with the specifications and bid documents in **Harrison Homes Redevelopment Phase II**. The Bidder agrees to furnish all labor, materials, equipment and services required to complete the work and project as described and required by the Contract Documents. Proposal prices may be written in longhand and numerically.
